## ADVISORY INFORMATION

This Emergency authorisation relates to the use of 'Coragen' (M19498) to control Beet moth (*Scrobipalpa ocellatella*) on sugar beet. Application via tractor mounted boom sprayer in water volumes of 300-800 litres/ha.

IMPORTANT: When applying this product under the terms of this Emergency authorisation, comply with any resistance guidance or restrictions stated on the product label.

Total reliance on one pesticide will hasten the development of resistance. Follow the resistance advice on the product label.

IMPORTANT: Goods treated under the terms of this Great Britain (GB) only authorisation can be legally marketed in Northern Ireland if they are being moved under the Northern Ireland Retail Movement Scheme. All other treated goods can only be marketed in Northern Ireland if they are in accordance with the statutory EU Maximum Residue Level (MRL) set under Regulation (EC) No 396/2005. This may also apply to residues in animal products where treated crops are fed to livestock. Growers are advised to draw this to the attention of distributors and retailers so that EU MRL breaches and any associated enforcement against goods marketed in Northern Ireland are avoided.

## **APPENDIX 1: CONDITIONS OF EMERGENCY AUTHORISATION**

The conditions below are obligatory. They must be complied with when the product is placed on the market and used pursuant to this Emergency authorisation. Failure to comply with the following conditions is likely to result in the withdrawal or amendment of the Emergency authorisation under Regulation No 1107/2009 and may result in other enforcement action, including prosecution.

For the purposes of this Emergency authorisation only, the conditions and/or requirements shown below supersede any corresponding conditions and/or requirements set out on the label or otherwise provided for under the product authorisation which would otherwise apply.

#### Operator Protection:

(1) Engineering control of operator exposure must be used where reasonably practicable in addition to the following personal protective equipment:

Workers must wear suitable protective gloves\* when handling treated sugar beet crops or manually removing weed beet or bolted beet plants until 6 weeks post treatment. \*Meeting at least glove safety standard EN374-1:2016 Type A and EN388:2016 (3121X).

(2) However, engineering controls may replace personal protective equipment if a COSHH assessment shows that they provide an equal or higher standard of protection.

## Environmental protection:

(1) Crops/situations with 5m buffer zone:

Since there is a risk to aquatic life from use, users not applying the statutory buffer zone must either themselves carry out or ensure that someone else has carried out a Local Environment Risk Assessment for Pesticides (LERAP) on their behalf before each spraying operation from a horizontal boom sprayer. Users must not allow direct spray from horizontal boom sprayers to fall within 5m of the top of the bank of any static or flowing waterbody or within 1m of a ditch which is dry at the time of application (these distances to be measured as set out in the guidance documents available from HSE Chemical Regulation Division's website and any amendments that are made to it) unless:

- (a) The LERAP indicates that a narrower buffer zone will be sufficient; and
- (b)Any measures indicated by the LERAP as justifying the narrower buffer zone are complied with in full and in accordance with any conditions applicable to them.

Spray must be aimed away from water.

Spray from hand-held sprayers must not be allowed to fall within 1m of the top of the bank of a static or flowing waterbody. Spray must be aimed away from water.

(2) The results of the LERAP must be recorded in written form and must be available for a period of three years for inspection to any person entitled to exercise enforcement powers under or in connection with the Plant Protection Products Regulations 2011 or the Plant Protection Products (Sustainable Use) Regulations 2012. (An electronic record will satisfy the requirement for a written record, providing it is similarly available for inspection and can be copied). (3) Detailed guidance on LERAPs and how to conduct a LERAP are contained in the guidance documents available from HSE Chemicals Regulation Division's website. All LERAPs must be carried out in accordance with this Guidance and any amendments that are made to it.

## Other specific restrictions:

- (1) This product must only be applied in accordance with the terms of this Emergency authorisation, the product label and/or leaflet.
- (2) A decision to treat must be based on crop monitoring and pest identification and recommendation to spray by BASIS-qualified growers or agronomists.
- (3) This product must not be applied via hand held equipment.
- (4) This product must be applied after BBCH 20 (9 or more true leaves unfolded).
- (5) Sugar beet tops treated with Coragen must be disposed of and not fed to livestock.
- (6) This product must only be used in accordance with the Stewardship requirements at Appendix 3 of this authorisation

## APPENDIX 2: GENERAL CONDITIONS FOR AN EMERGENCY AUTHORISATION

Failure to comply with the following conditions will be likely to result in the withdrawal or amendment of the Emergency authorisation under Regulation No 1107/2009 and may result in other enforcement action, including prosecution.

#### Adverse effects:

The authorisation holder must immediately notify the Secretary of State if they have any new information on the potentially adverse effects of the authorised product, or of residues of an active substance in that product when used in accordance with the conditions of this authorisation. Failure to comply with this requirement is an offence.

## **Provision of information:**

The authorisation holder must comply with all requests for information required by, or on behalf of, the Secretary of State in accordance with Assimilated Regulation No 1107/2009.

## **APPENDIX 3**

## Emergency Authorisation Stewardship Requirements For Use Of Coragen (MAPP 19498) And An Insecticide To Control Beet Moth On Sugar Beet.

Any Person applying 'Coragen' to sugar beet must follow the conditions of the Emergency authorisation.

In addition, stewardship is required to ensure that use is limited and controlled, including disposal of treated sugar beet tops and recording use.

The stewardship includes roles for the product authorisation holder, distributers, individual growers and groups representing the growers.

Dispose of sugar beet tops and record the fate of these	Crop owners/ growers

Collate records data for submission to HSE	British Sugar/ NFU Sugar

## Promotion and communication of the Stewardship

The requirements for growers to record usage and how treated sugar beet tops were disposed of and to supply this information must be appropriately communicated by British sugar plc and NFU sugar or where more appropriate by BBRO.

In support of any future application for this use the applicant must provide a summary report of the 2025 season with regards to beet moth infestations and any subsequent use of Coragen in its control. This should discuss the extent of use, covering locations and areas, the parameters used in the decision-making process and the success of treatment. If variations in performance can be seen further analysis may be required to identify those potential parameters which affected the performance of the product either positively or negatively.

It may be that information gathered by British Sugar contract managers, perhaps through data required under the Red Tractor assurance scheme, could help with the above.

### **Crop owners / growers**

The authorised use period must be respected.

The following must be recorded by the user and submitted to British Sugar by 31 December 2025.

The date and locations of treatment, the number of treated hectares, percentage of crop affected by beet moth, and fate of the sugar beet tops.
