The work of a Crop Trials Technician

Reporting to BBRO's Glasshouse and Laboratory Manager, you will assist with laboratory, glasshouse and field trials by supporting the laboratory and glasshouse activities, conduct practical work associated with agricultural field trials and demonstrations and assist with delivery of BBRO's KE activity on host farms/open days.

Primary areas of work:-

- Assist with the culture of pests, virus and diseases cultures and isolates
- Assist with the maintenance of plants in the glasshouse
- Assist with general laboratory housekeeping duties and with BBRO plant clinic
- Conduct field assessments and technical measurements as required to support BBRO scientists
- Assist the Field Trials Team as required during busy work periods e.g., drilling/harvesting/test digs
- Drone operation (training provided where required)
- Travel to trial sites across the beet growing area

Skill set required

You will need experience of working in a laboratory and glasshouse environment with some understanding of plant biology and a good level of understanding of agriculture practice. This role requires that you hold a full driving licence and you must be prepared to travel across the East of England. Furthermore, you will need to be able to conduct the field work.

Desirable, though not essential proficiencies include an agricultural college qualification, telehandler qualification, and PA1 and PA6 pesticide application qualifications.

This role is for you if you are keen and self-motivated team worker with a positive, resilient, "can-do" attitude. You will need to be able to effectively prioritise and conduct tasks, give attention to detail, meet deadlines and follow instructions.
